



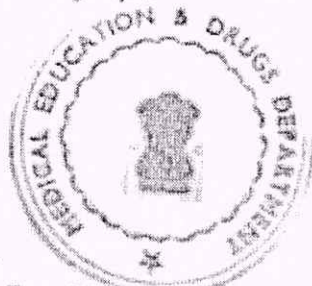

3. This Certificate is valid for a period of 3 years from the date of issue where after it will automatically laps.



I am directed by the Council to grant Assent for B.Sc.(N) increase seats 3rd batch of your institution for the academic year 2023-24 with an intake of 60 (sixty) seats subject to following conditions.

1. The intake capacity shall be 60.
2. This continuation is only for the A.Y. 2023-24 subject to permission from MUHS / Deemed University / State Govt.
3. This continuation of B.Sc.(N) Program will automatically come to an end without notice in case of your failure to comply with the conditions prescribed by affiliating authority.




